CAT ADOPTION CONTRACT**

1. In exchange for the non-refundable adoption fee of \$ _____, WARS, Inc. agrees to transfer custody of the homeless cat identified above to the Adopter. The Adopter agrees that no sale or purchase is involved.

2. The adopter acknowledges that WARS, (a) does not know the cat's medical history; (b) has not conducted a thorough veterinary examination of the cat; (c) makes no statement or comment regarding the past; present or prospective future health of the cat; (d) offers no warranty, including implied warranty, regarding the cat; and (e) accepts no liability for the health of the cat or for veterinary costs incurred after adoption, including costs relating to medical conditions existing at the time of adoption. The adopter acknowledges that the age of the animal shown on the medical record is a good faith estimate and the adopter absolves WARS from liability for error in estimating the age. The adopter further indemnifies WARS against any and all costs for veterinary services performed on the animal for any reason from the time of adoption.

3. The adopter shall (a) have the cat examined by a veterinarian within seven days of adoption and treated for any existing conditions, and (b) establish and maintain a vaccination schedule. State law requires the cat to have a current rabies vaccination throughout its life from age 12 weeks. Should the animal be too young for surgical alteration, the animal will be altered within the next consecutive 12 weeks. Animal will not be declawed without prior consent.

4. The adopter shall quarantine the cat from other animals for a period of two weeks. The adopter absolves WARS from liability for the transfer of any disease/condition from the cat to any person or other animal during or at any time after this period. The adopter further indemnifies WARS against any and all medical and/or veterinary costs relating to the transfer of any disease/condition to any person or other animal.

5. The adopter shall (a) keep this cat as an indoors-only (unless prior consent is given), household pet; (b) provide the cat with such veterinary care as needed to maintain good health and well being throughout its life; (c) provide the cat with humane care; and (d) maintain the cat in accordance with all applicable current and future laws and ordinances.

6. If the adopter becomes unable or unwilling to keep the cat, the adopter shall return it to WARS at its place of business, together with the original and current veterinary records. The adopter consents to reclamation of the cat by WARS at any time for failure to comply with the terms of this contract.

The adopter indemnifies WARS from any responsibility for the cat, directly or indirectly, for veterinary expense, mortality, allergy, condition resulting from contact with the cat, actions of the cat, or for any other reason(s). The adopter indemnifies WARS against any and all claims, known or unknown, now or hereafter, arising in connection with the cat. The adopter agrees to reimburse WARS for any and all expenses, including court costs and attorney fees, incurred in enforcing the terms and provisions of the contract. The laws of the State of South Carolina shall apply to any dispute arising out of this contract.
